

Eurex Circular 013/18

Decommissioning of old 10 Gbit/s Eurex Co-Location infrastructure

Summary

After the successful introduction of Co-Location 2.0 in June 2017 and the announcement of the ordering stop of the old 10 Gbit/s Eurex Co-Location infrastructure (hereafter referred to as Co-Location 1.0) in December 2017, Eurex Frankfurt will decommission Co-Location 1.0 by **30 September 2018**. After this date, it will only be possible to connect to the Co-Location 2.0 infrastructure.

In order to facilitate a smooth transition from Co-Location 1.0 to Co-Location 2.0, Members who migrate and/or cancel all their Co-Location 1.0 connections **between February 2018 and June 2018** will be granted a free-of-charge one-month migration period for replaced Co-Location 1.0 connectivity.

1. Decommissioning of old 10 Gbit/s Eurex Co-Location infrastructure

After the successful introduction of Co-Location 2.0 in June 2017 and the announcement of the ordering stop of the old 10 Gbit/s Eurex Co-Location infrastructure (hereafter referred to as Co-Location 1.0) in December 2017, Eurex Frankfurt will decommission Co-Location 1.0 by **30 September 2018**.

This includes the Eurex Enhanced Trading Interface (Eurex ETI), Eurex Enhanced Order Book Interface (Eurex EOBI), Eurex Enhanced Market Data Interface (Eurex EMDI) and Eurex Enhanced Market Data Interface & Eurex Enhanced Order Book Interface (Eurex EMDI & Eurex EOBI). After this date, it will only be possible to connect to Co-Location 2.0 infrastructure.

2. Migration period until 30 June 2018 when replacing 10 Gbit/s Co-Location 1.0 infrastructure with Co-Location 2.0 infrastructure

In line with the common procedure for all connections, 10 Gbit/s connections in Co-location 2.0 will be charged starting with the first full calendar month after services are provided (status: "ready for service").

In order to facilitate a smooth transition from Co-Location 1.0 to Co-Location 2.0, Members can maintain replaced Co-Location 1.0 connections free-of-charge for the month after the respective Co-Location 2.0 connections have been provided.

This incentive requires a Member **between February 2018 and June 2018** to:

- migrate and/or cancel all its Co-Location 1.0 connections, and
- replace the Co-Location 1.0 connections to be maintained free-of-charge with Co-Location 2.0 connections, which are provided latest on 31 May 2018 (charged from 1 June 2018 onwards)

With this approach, Members can migrate to the new Co-Location 2.0 infrastructure by using a one-month migration period without additional connectivity fees caused by the redundant setup.

The fees for replaced Co-Location 1.0 connectivity charged in the one-month migration period will be reimbursed via a separate credit note posted in July 2018.

Migration period illustration:

A Member orders Co-Location 2.0 connectivity via the Member Portal at the end of March 2018; this connectivity is provided to the Member on 5 April 2018 (i.e. first invoice period for Co-Location 2.0 connectivity is 1 May – 31 May 2018). Later on, this Member cancels its Co-Location 1.0 connections that had been replaced by the Co-Location 2.0 connectivity on 28 May 2018. For the invoicing month May 2018, the Co-Location 1.0 and 2.0 connectivity will be charged to the Member regularly. However, the Member will receive a reimbursement of the fees charged in the May 2018 invoice for its replaced Co-Location 1.0 connections via a separate credit note posted in July 2018.
